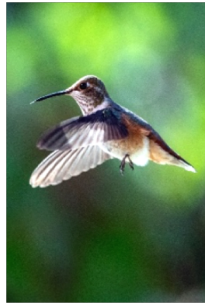
## Message from GRM Judy continued....

## Diabetes Type 2 – Interesting Facts

- More than 37 million people in the United States have diabetes, and 1 in 5 of them don't know they have it.
- 96 million US adults—over a third—have [prediabetes](#), and more than 8 in 10 of them don't know they have it.
- Diabetes is the 7<sup>th</sup> leading cause of death in the United States (and may be underreported).
- [Type 2 diabetes](#) accounts for approximately 90% to 95% of all diagnosed cases of diabetes; [type 1 diabetes](#) accounts for approximately 5-10%.
- In the last 20 years, the number of adults diagnosed with diabetes has more than doubled as the American population has aged and become more overweight or obese.

These facts emphasize the importance of the work we do to award grants for diabetes research projects. Please support the Diabetes Research projects being planned this year. Together we can make a big difference!

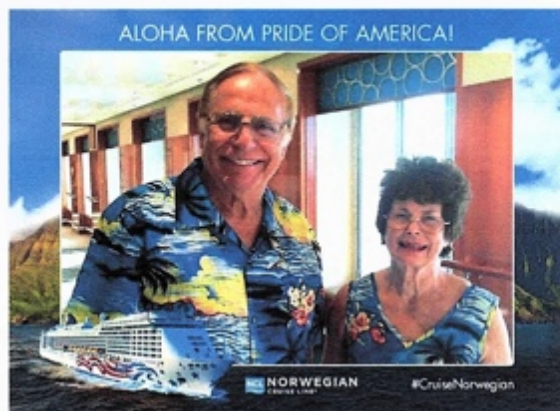

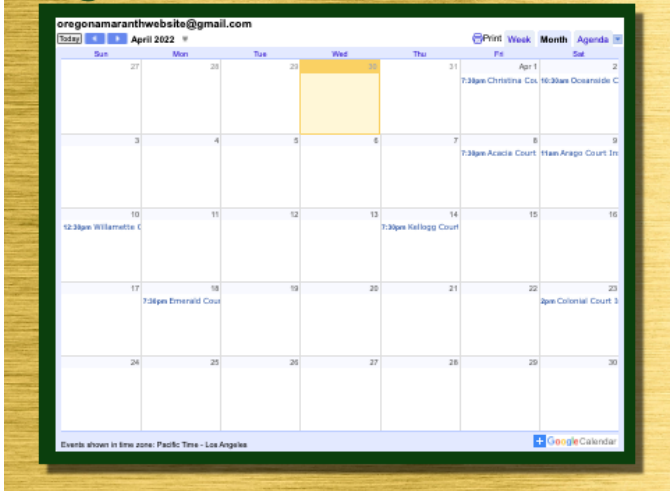




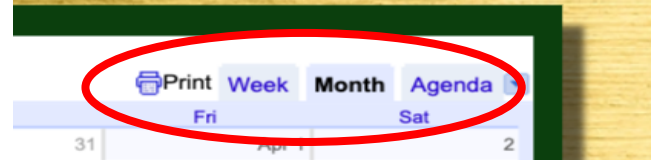

## The New Grand Court Calendar

## Calendar of Events



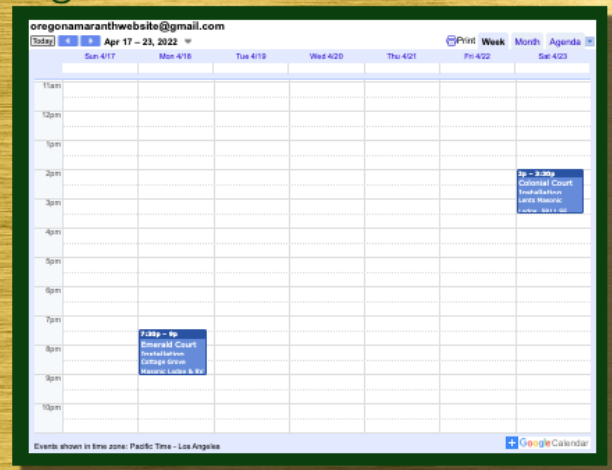
On the upper right-hand corner of the calendar are additional links that can help you get the calendar into a format that you prefer!

When you first open the calendar, it will display the current month in a monthly block. You can change the view to be a weekly calendar or an agenda view, which lists the events on the calendar in chronological order.

The Grand Court calendar has been converted to a Google calendar, which provides a lot more flexibility and added features to help you as a member. Here are some quick tips on how to use the [new calendar](#) effectively.

When you tap on the "Calendar and New" tab, the Google calendar will appear. The view for the calendar is set to default to a block-looking calendar, with the current month displaying.

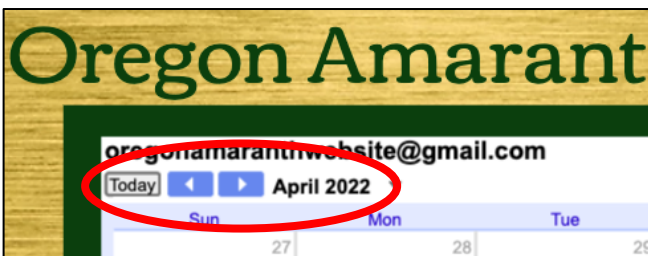


Above is the sample weekly view.

Looking at the upper left-hand corner of the calendar, you can change the calendar month by using the blue right/left arrows (< >) to navigate to a different month. There is also a dropdown arrow with the month and year displayed (April 2022) that allows you to advance through the months.

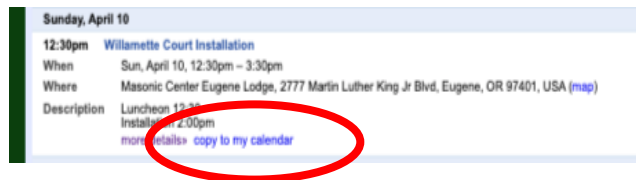
If you have been browsing the calendar and want to get back to the current date, use the "TODAY" link on the far left of these keys to bring you back to now!





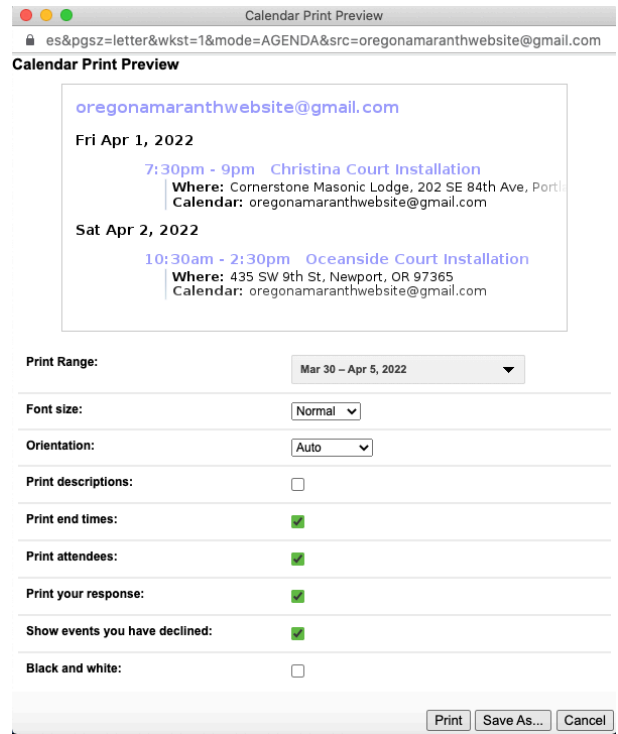
Zoomed in... this is the “Agenda” view.

On any view, you can click on an event that is on the calendar and a window will pop open that provides you with more details about the event. The information is updated by the Webmaster, based on the information that has been provided.



Note this screen allows you to add the Amaranth event to your personal Gmail calendar! Just tap on the “Copy to my calendar” link.

If you want to print a copy of the calendar, this is the print dialogue box that opens on my computer. Your print information may vary slightly. Please note that you can generally specify a date range for the calendar being printed.



I hope that this tutorial on using the Grand Court’s new Google calendar is helpful. Please know that learning new things can require patience and practice. Please be patient with yourself and ask for help if you get stuck. We are all learning together.
