Amendments to the Constitution of the Supreme Council

As we prepared for Supreme Council Assembly, voting delegates were busy reviewing 39 proposed amendments to the Supreme Constitution. With an experienced Chairman of Jurisprudence and an efficient and knowledgeable Supreme Royal Matron, what looked to be a long-suffering process was handled smoothly and efficiently! It was a joy to be there to watch this. A copy of the proposed amendments will be provided under separate cover. Below are the results of the 39 proposed amendments. All were adopted, unless noted otherwise.

- Before discussions were begun, Amendments #16, #17, #25, #28, #32, #35, #36, #38 and #39 were withdrawn.
- Amendments #1 - #6 were voted upon en bloc (together) as they were all housekeeping and related. All six were approved as submitted.
- Amendment #7 – removes membership requirements listed elsewhere, simplifying the Landmarks of the Order, paragraph 5.
- Amendment #8 – this amendment also removes membership requirements listed elsewhere, making the Objects of Organization and Incorporation more easily read and understood.
- Amendments #9 - #10 were approved together. These dealt with membership in Australia. Amendment #9 was amended to grant permission to Courts in *Australia*, rather than New South Wales.
- Amendment #11 clarifies language about when Supreme Council Assembly will meet, no earlier than the 4th Monday in June and no later than July 15th.
- Amendment #12 was adopted as amended. As amended, it simplified the information that Supreme elected Officers must provide to the SRM and Supreme Secretary, including their current home address, phone(s) and email address. Notably, email is now a legally accepted practice of communication.
- Amendments #13, #30 and #34 were adopted en bloc. These amendments put in Parts II (Supreme Council), III (Grand Courts) and IV (subordinate Courts) the same language regarding election to office, even though not present at the time of Election, provided a letter of acceptance has been previously placed on the Secretary's desk.
- Amendments #14, #31 and #33 were adopted en bloc. These amendments put into Parts II (Supreme Council), III (Grand Courts) and IV (subordinate Courts) the same language regarding election to office and resignation required prior to accepting the election to another office.
- Amendments #15 and #29 were adopted together. It moves language regarding the election of Grand Officers from Part II (Supreme Council) to Part III (Grand Courts).
- Amendment #18 was adopted as amended. This deals with how ADF funds are transferred from the Supreme Secretary to the Supreme Treasurer "by bank check or electronic funds transfer (EFT)", then to the Secretary of the of the Amaranth Diabetes Foundation. The clarification was that the Supreme Secretary does not "pay" funds, but forwards funds.
- Amendment #19 adopted as amended. This amendment rewords the language in (G) and was amended to add the word "Supreme" in the first sentence to state, "...of the Board of Supreme Trustees...."
- Amendments #20 and #21 were adopted together. Both deal with deleting specific form numbers and uses the word "forms" instead to allow for the further development of forms as needed.

- Amendments #22, #23, #24, #26, #27 were adopted en bloc without amendment. All of these amendments address allowing electronic communication and electronic signature, including “digital signature” for Supreme Council procedures, including allowing for electronic submission of reports and communications, Committee communications, etc. The rationale states, “Electronic communication is now a legally acceptable practice.”
- Amendment #37 was adopted, with amendments. This is a new section to Part IV (Rules and Regulations Governing Subordinate Courts) to the Constitution which allows Subordinate Courts (SCJ) to “attach themselves” to a neighboring Grand Court, becoming part of that Grand Court and specifying the procedure to accomplish this.

Ritual Changes Completed

Last year at the annual Supreme Assembly, the 10-year review of our Ritual was begun. However, the proposed changes were so numerous that they could not be completed. Fifty amendments were considered and the remaining thirteen amendments to the Ritual presented in 2024, were carried over to the 2025 Supreme Assembly session. The results of the remaining proposed changes to the Ritual were voted upon and the results are provided below.

- #51 – Pages 236, 237, 239, 240 and 241, in the Opening Ceremony of a Grand Court or Supreme Council – add (Sir Knight) to the verbiage when addressing the Grand Marshal, if a SK is the Grand Marshal. Currently reads only “Honored Lady Grand Marshal.” Passed.
- #52 – Page 237 – new instruction on when Grand Officers turn inward, providing, “When the line is formed, the Grand Marshal will nod to the Grand Officers who will then face inward.” Passed.
- #53 – Page 239 – provides more clarifying instruction when the GSwB comes to “Present Swords” while the crown is being placed during the Opening Ceremony. Passed.
- #54 – Page 239 – add after in proper form: “over his left arm.” Passed.
- #55 – Page 241, paragraphs 3 & 4 – updates the instruction to the Grand Marshal on presenting the gavel to the GRM in the Opening Ceremony. Passed.
- #56 – Page 241, paragraph 8 – adds instruction for the GAM and GAP to “face North and South, then step together to within one step of each other and then face West” as the Grand Conductresses move to escort the GAM and GAP to their stations in the WEST. Passed.
- #57 – Page 242, paragraph 5, changes language to clarify the GME is on the Right of the GStB and GMW is on the left of the GStB and that together they form the Color Guard to the Color Bearer (GStB). Passed as amended. Last sentence to read, “Active Members and Veterans may use the military salute.” Also, reference to Fig 2, page 42 is removed.
- #58 – Page 243, paragraph 8 – directs the GRM to pause after calling of Officers for their charge in the Opening. Passed.
- #59 – page 252 – Closing Ceremony of Grand Court or Supreme Council – permits the public to attend the Closing Ceremony; however, only Members of the Order may perform the Work, *with exception of the Musician*. Passed as amended (*added italics*)
- #60 – Page 255 & 260 – Memorial and Ceremony for Draping the Altar. Changed to read: “(White Gowns are required for all Honored Ladies *participating* in the Memorial Service.)”. Passed as *amended*.
- #61 – page 255, paragraph 10. Provides clearer direction for the MW to move when the StB moves for Memorial Service. Passed.

- #62 – page 256, paragraph 2. Adds direction for the Warder to open the door for officers to enter with the Altar drape. This was amended to add, “*The Warder closes the door after officers have entered the Courtroom.*” Passed as amended.
- #63 – page 259, paragraph 8. This change clarifies what movements are made after the RM places the flowers on the Altar for Memorial. It was amended to add “*right*” so the first sentence reads, “The RM then right about faces...”. Passed as amended.
- #64 – page 259, paragraph 10. Clarifies placing of flowers by Members following Memorial Ceremony. This was amended to permit placing of flowers for any member, regardless of when they passed or were recognized in a Memorial Ceremony. The paragraph was also re-organized... and clarification for the RM that she “*right*” about faces and returns to the Throne. The amended proposal was adopted.
- #65 and #66 were disposed of in 2024.

Oregon Members Selected to Serve Supreme Council for 2025-2026

Congratulations to 3 of our Oregon Honored Ladies who were elected to serve our Supreme Council Assembly. Several members were also installed as Deputy Supreme Royal Matrons and Deputy Supreme Royal Patrons. Other Committee appointments will be announced at a later time.

- HL Hollie Dahm Stivers was elected as Supreme Conductress. Look for her reception information in our last newsletter, or at the Amaranth.org website (left side bar - bottom of the page)
- HL Charlene Tucker completed 10 years of service to the Amaranth Diabetes Foundation Board of Directors and was then elected as a Supreme Trustee - 4 years!
- HL Carol Addison Lippert was elected to serve on the Amaranth Diabetes Foundation Board of Directors for a 3-year term! Congrats ladies!!!

Why Membership Is More Than Numbers

*"My grandma and grandpa weren't biological...
but I didn't know that. They were Masonic."*

I grew up as part of a Masonic family. Literally.



There's a photo of us — my dad, the Master of his Lodge... my mom, Royal Matron of her Court... my sister, the Honored Queen... and me, the Master Councillor.

It wasn't a weekend if we didn't have a Masonic event — sometimes it wasn't even a *night* off. Dinner was often a fast-food meal in the car on the way to an OV. But we didn't mind. It wasn't about convenience. It was about *belonging*.

Even now, after years of traveling and living across the U.S., the Masonic family is still a part of my life. I may not always have the time to attend every meeting, but I stop by when I can. I drop in wearing business casual — sometimes looking like an outsider — but carrying the soul of someone who knows this is *my family*. And yet...

Sometimes I'm not met with a smile.

Sometimes I'm met with suspicion.

That momentary scrutiny — "*Why are you here?*" — hits different when you've grown up in the fold. Because deep down, I know I belong. But I don't always *feel* welcome.

And maybe that's the heart of it.

We spend so much time worrying about the politics, the protocol, the amendments, the dress codes... that we forget the *people*. We forget what *really* matters.

We forget the **research we fund**,
the **communities we support**,
and the **family we build**.

My grandma and grandpa Donnelly weren't blood — but they were mine.

My "Uncles" Jim Lamb, Todd Cooper, Allan Beebe — not biological, but family.

Larry and Mary Weaver, &
Ivan and Betty Rink — family.

Gary and Connie Massey, who made space for me when I was down.

Carol and Rod Lippert, who lit up when they saw my daughter, Edilyn.

My New Jersey crew, who *still* make time for me five years later.

That's what makes this organization magnetic — not the ritual, not the titles -the *relationships*.

I haven't been as active as I once was, and part of that is because I miss what I had.

Amaranth wasn't just an organization...

it was **home**.

If we want to grow again...

If we want to attract the next generation

If we want to bring back those who have drifted away...

We need to make them *feel that* again.

So I'll leave you with this question:

What legacy do you want to leave?

What is Amaranth to you?

Because for me...

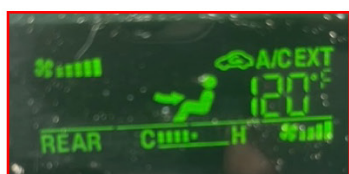

State Farm Stadium was next door to our conference hotel... and the overwhelming heat. It hit 120 with every day in triple digits.







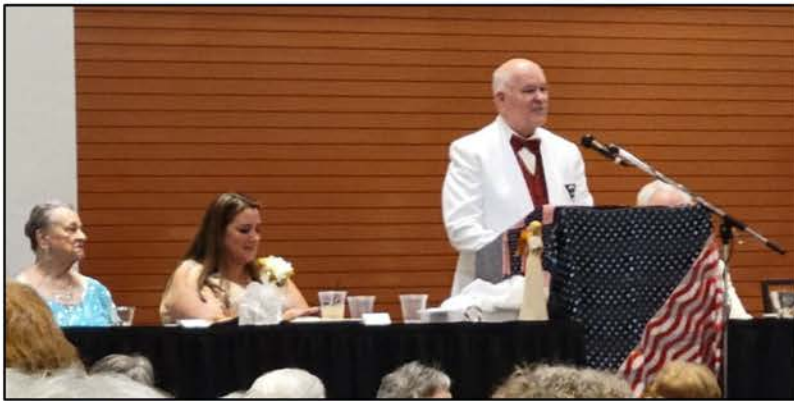
The Renaissance Phoenix Glendale Hotel and Spa was our conference facility for the 127th Supreme Assembly Session.
